MINUTES OF THE 2022 ANNUAL GENERAL MEETING FOR PAULIN MEMORIAL PRESBYTERIAN CHURCH

The annual congregational meeting of Paulin Memorial Presbyterian Church for 2022 was held on Sunday, March 5, 2023 at 11:45 am. An in-person meeting took place in our church sanctuary. There were 36 people present.

Opening Prayer and Devotion: Rev. Lisa Aide opened the meeting in prayer. She read the Mission Statement of the Presbyterian Church in Canada as an opening devotion. As a Reformed church, we rely on the truth and inspiration of Scriptures for God's guidance into the future — a future that we approach with wonder and anticipation, knowing God is with us. Relying on the power of the Holy Spirit, we proclaim the law and good news of Jesus Christ through our words and actions. As worshiping communities joyfully celebrating the sacraments, we are supported, strengthened, and equipped to share the love of God revealed in Jesus Christ.

Land Acknowledgement: Rev. Aide opened the meeting by acknowledging that the land on which we gather is the traditional territory of the 3 Fires Confederacy of First Nations, comprised of the Ojibway, the Odawa and the Potawatomie.

Appointment of Secretary:

Mary Ellen Sands King moved to accept Nancy Blair as secretary, seconded by Moira Diffey. Motion carried.

Approval of Minutes:

Guy Simon's moved approval of the Minutes of the Congregational Meeting held Sunday, March 5, 2022 and located on pages 5-6 of the 2023 annual report. Seconded by Jim Aide. Motion carried.

Errors in Report:

That Chrys' last name be corrected from Lake to Stammler.

That the error in the financial report should be read an amount of \$700, not \$750. A motion was made by Jim Marchand and seconded by Moira Diffey to make the correction in the report. Motion carried.

Report of the Board of Managers:

A motion was made by Guy Simon's to accept the financial report and was seconded by Jim Marchand. Motion carried.

A motion was made by Bob McVicar to accept the budget for 2023 and seconded by Jim Aide. Motion carried.

Election of New Board Members:

No new board members to be elected at this time.

New Business:

Anne McLachlan gave an update on the legal actions that were taken against the church.

Jim Aide moved to adjournment of the meeting at 12:45.

Rev. Lisa Aide closed the meeting in prayer.

2023 Session Report

During 2023, the elders on session meet for 9 in-person meetings and 2 joint meetings with the board of managers. As always, meetings began with a spiritual devotion and prayers for those with pastoral concerns. The members of session have endeavoured to continue to provide a space for worship, faith formation, and mission work. Highlights from the session meetings are posted on the office bulletin board and on the church website. A newsletter is distributed 4-6 times a year.

In 2023, Paulin Memorial continued our support for the work of Presbyterians Sharing and Presbyterian World Service and Development (PWS&D), both essential components of our denomination's mission work. Presbyterians Sharing provides support for the administrative work of our national church, support for congregations, and mission work both within Canada and globally. While our allotment from the PCC for Presbyterians Sharing for 2023 was \$16,180, the congregation committed to submitting a minimum of \$4,000. Through our envelope designations, fundraising, Birthday church & direct donations by individuals, we were able to provide \$6,054.76 in support. Our allotment for 2024 is \$18,079 but the session is once again recommending the amount of \$4,000. PWS&D is an NGO that supports humanitarian relief & development work around the world. Our congregational donations and direct individual donations amounted to \$6,789.91. As outlined in the Mission & Outreach committee report, we have also responded generously to other needs and appeals within our community and congregation.

In 2021, we applied for the Presbyterian Church in Canada's (PCC) New Beginnings Program in order to discern God's future for our congregation. We received support from the Essex Kent Presbytery and a grant for \$4,500 from the PCC to participate in this program. Rev. Aide gathered the relevant documents and Rev. Mavis Curie visited our congregation on December 2, 2021. Unfortunately, because of uncertainty related to the pandemic, the process was put on hold. We were required to submit further documentation in November 2022 and the program was restarted in March 2023. After delays related to availability of coaches, we kicked off the Transformation weekend with Rev. Paul Kang on November 3-5. Led by 5 House Leaders (Nancy Carle, Audrey Landon, Jim Marchand, Janet Brigham-Turowski & Anne McLachlan), 48 people attended 4 meetings from November 9, 2023 to January 10, 2024. The House Leaders will write a report to be presented to the congregation in February 2024. An

Implementation Team will be formed and coached by Rev. Kang over 6-8 months to implement the future story.

Two children were baptized in 2023: Luke, son of Adam & Cady Wingelaar in October and Andrew, son of Michelle & Dan Blokker in November. Rev. Lisa Aide and Jonathan Calder celebrated their marriage at Paulin on October 7, 2023. In April, we welcomed 12 new members by profession of faith or transfer: Kristina Garswood, John Garswood, Arnold Eagle, Linda Eagle, Rob Kissau, Margaret Kissau, Elizabeth Rivet, Susan Lucas, Lillian Ridgwell, Nancy Bryans, Betty Ann Michaud, & Lynn Chappell. In November, we welcomed another 6 members by transfer or profession of faith: Donald Towlsey, Jeanmarie Towsley, Mary Singh, Festus Moasun, Yvonne Moasun, & Paul Henderson. Through death, we were saddened to lose the following members in 2023: Ken Havens, James Fleming, Jon Landon, Dorothy Lake, Richard Gowman, Shirley Paterson, Ted Douglas, Geraldine McAusland, Jack McMillan, & Pat Leary. As we remember these people, we thank God for their lives and lift up their families in prayer. We also pray for other families in our church who have lost loved ones that are not mentioned above.

As our Synod fees are determined by the number of people on the membership roll, inactive members (no attendance or donation in 2 years) were contacted to determine if they wished to stay as members. Ten people were removed at their request or due to transfer to another church. Eleven were removed from the roll due to inactivity and no contact.

In April 2023, working together with our lawyer and insurance company, a settlement was reached with a former employee who file a lawsuit through small claims court. Due to a nondisclosure agreement, no further information can be provided.

Letters of resignation from ruling elders were received from Anne Boden & George Boden in March, Norm Diffey in June, and Amy Vreman effective February 2024. Lisa Golab returned from a leave in January. A. McLachlan resigned as Clerk of Session in December 2023. Paulin Memorial Presbyterian Church: Choir Report, 2023

Members of the Paulin choir worked diligently over the year to present special music on a number of occasions. A highlight was our Christmas cantata, *Love came down*, with music by Stan Pethel and a text by the poet Christina Rossetti. The choir prepared anthems for each Sunday of the year, and their ministry of music was highlighted particularly for services including Good Friday and Easter, Thanksgiving, and communion.

It is my pleasure to work with this diligent and talented group. When we are at full strength we have ten singers. Although all members do their best to be present, we often have less than full attendance because of a combination of holidays, illness, travel, or work. For this and other reasons, I would be very pleased to have a few more people come forward as potential choir members.

Practice is Thursday evenings at 7, and I usually release the singers around 8:20, giving them time to store their folders and gather their things by 8:30. If you would consider joining us, please come and see me. We work together and have a diverse set of skills, so do not hesitate to give the choir a try. It is a very good way to experience fellowship and enjoyment, and to serve the church. This year we welcomed Yvonne and Jeanmarie and it is great to have them.

I extend grateful thanks to Carolyn and Carol, the librarians. It takes a good deal of time to keep everything organized, stamped, distributed and collected. We have a rich collection of music at Paulin and they do a marvellous job. I would also like to thank Jim Marchand for working on the choir area in the sanctuary for us, as well as building shelves. Another person who helped us is Ron Dossenbach. He is able to trouble shoot problems with the organ and quick to respond to requests for help. Our instrument tuners Al Veltman (piano) and Jan Vanderstad (organ) tuned our two beautiful instruments in the spring and fall, and continue to keep them in good condition.

Faith Community Action Committee

Carolyn Burgess, Karolyn Gagnier, Anne McLachlan & Rev. Lisa Aide. As our philosophy has shifted to asking the recipients of our monthly projects about their needs, we have changed our name from Mission & Outreach to Faith Community Action. Our ongoing project within our building is to provide menstruation products in the washrooms. In January, we collected pet food and hygiene products for The Welcome Centre, a shelter for women and families. 80 people attended the Pancake Supper in February and \$461.49 was raised for Presbyterians Sharing. 15 people participated in the Coldest Night of the Year walk at the Unemployed Help Centre (UHC Hub) and raised \$715. A Soup/Chili

supper held in March raised \$521.03 for Camp Kintail. With the news that over 850 refugees had relocated to Windsor, we responded by collecting household and personal items for Matthew House Refugee Centre in March. In April, we heard how Paulin members are the hands and feet of God in the community through their work with Compassion Canada (Don & Ev Adams), the Windsor Optimist Sunshine Camp (Norm Diffey) and the United Way On Track to Success program (Anne McLachlan). In May, we contacted Street Help and collected snack items, water bottles and sleeping bags/back packs for them. In June, several hundred community members attended our Indoor Yard Sale and we raised \$650 for PWS&D. Healthy snacks were collected in August for Westgate P.S. to start off their school year. We learned about the Living Wage project and encouraged our congregation to pay our church employees at least a living wage as calculated by the WE Public Health Unit (\$18.65 for 2023). To acknowledge the role of our Presbyterian denomination in the residential school system, we wore Orange Shirts at the September 24th Worship service. A successful Pew Challenge in October resulted in 214 pairs of socks, 148 underwear, and \$30 donated to patrons of the Soup Shack. In November, cheques & gift cards totalling \$1,375 and 7 boxes of items were dropped off at Hiatus House. Twenty PCC Calendars were sold and a profit of \$100 was sent to Camp Kintail. A. Landon co-ordinated the Mitten Tree and Paulin people generously donated 54 pairs of mitts, 30 pairs of socks, 4 scarves, and 65 hats. Items were dropped off at Roseville, Begley, Victoria and Westgate elementary schools with the scarves & some hats donated to Street Help. Keeping with tradition, the loose offering from the Christmas Eve service was split between Presbyterians Sharing and Paulin's Operating Fund with each receiving \$191.50. Thanks to K. Gagnier for liaising with Street Help & the Soup Shack & to S. Bowyer for dropping off items to the various agencies. Respectfully submitted by A. McLachlan

CHRISTIAN EDUCATION REPORT

2023 has seen great growth in our Sunday School program, now each week we can have a range of children from 3-10 depending on who is with us from week to week. The children continue to grow in their faith and their love of God under the guidance of Audry Landon, who is always ready with a craft and a story to help them learn about the wonderful ways in which God has impacted our world. Audry has also been teaching the children some of the songs of the faith and it was a great gift to have them sing as part of our worship service. Each Year we are making sure that we are

following the Leading with Care policy, by making sure that each teacher and monitor signs a covenant of care form and reviews our church policy.

Bible studies at the church are still going strong at Paulin. The morning bible study has grown to have as many as ten people on a Wednesday morning. We have covered topics from Ezekiel to looking at the many names that Jesus has taken upon himself during the advent season. Currently we are making our way through the gospel of Mark and all are welcome to come and join us. The evening Zoom bible study is holding steady at four people. Last year we made our way through the pastoral letters and the book of Romans. But this bible study has turned into a great way to reach those in our congregation who are no longer able to attend an in-person study due to mobility issues.

2023 was our first VBS after Covid, and while we were not blessed with as many campers as we might have wished, we know that with time and prayer we will be able to get back to what we once had before the pandemic.

Board of Managers Report 2023

The Board of Managers consisted of the following members: Margaret Douthart, Deb Naklie, Joanne Zuk, Don Adams, Allen Burgess, Bill Kunsch, Jim Aide, Mike Golab, Terry Henry, Jeremy Fisher, Eric Tulp and Bob MacVicar.

During the year the following resigned, Jim Aide & Eric Tulp, Jeremy Fisher moved to Barrie, Mike Golab left the Board to take on chairing the Worship Committee of Session. Terry Henry retired after fifty years of service to two congregations and the Presbytery of Essex-Kent. He is taking a well-deserved rest. The Board is in the process of filling these vacated positions and have had some success with the return of Jim Marchand and the addition of John Garswood. We are hoping others will consider joining the Board.

The renovations to the upper hall stage were completed by Riverfront Theatre group at no cost to the congregation, with our thanks. It is hoped that with a usable stage and lighting, other groups will consider renting our upper hall for theatrical productions and events. The Board also had the opportunity to provide

rental space for computer coding classes as well as a summer day camp which brought in a significant amount of rental income. After the successful relationship built with this provider, it has been agreed that the same camp will be offered this summer along with using our church during school breaks and professional development days. These ventures, coupled with an increase in volunteer hours, allowed us to operate with fewer staff positions and have resulted in positive results. Some members of the Board have participated in the New Beginnings programme by attending group sessions. This programme is funded in part by a \$4500 grant from our national church supported by our Essex-Kent Presbytery. It is expected that this programme will help us identify where we are a d what we need to consider as we move forward. An actionable plan is expected in 202 and the Board is considering how best we can serve the changes this may present.

REPORT OF THE TRUSTEES FOR 2023

As part of their responsibilities, the trustees must make sure the church and property are properly insured. Once again this year, arrangements have been made to spread the insurance premiums over a 10 month period. This allows the treasurer to plan more effectively to disburse the church finances. Unfortunately, the cost of insurance has increased more than the cost of inflation over recent years, but this cost for 2024 seems to have moderated. It should be noted that the church property has an appraised value of more than \$7,000,000. The insurance cost for 2023 was \$16,714.10.

In accordance with the trust deed for Paulin, trustees are elected for a 6 year term, with two trustees being elected in every second year. The next election is scheduled for 2025 so no election is needed this year.

NOTES to the FINANCAIL Statements (unaudited) Dec 31 2023

1. SIGNIFICANT ACCOUNTING POLICIES: These financial statements have been prepared in accordance with accounting policies that are considered appropriate for Paulin Memorial Church and include the following significant accounting policies. Our accounting process is Cash Basis Accounting. (a) Fund Accounting: The accounts of the congregation are maintained in accordance with the principals of "Fund Accounting" in order

that limitations placed on the use of resources are maintained. The Operating Fund accounts for all operating activities. Reserves consist of amounts removed from general surplus to be used for specific purposes as approved by the board. (b) Capital Assets: Capital assets are recorded at cost.

- **2. INCOME TAX STATUS:** Paulin Memorial Presbyterian Church is a registered charity within the meaning of the Income Tax Act (Canada) and is exempt from income taxes.
- **3. REVENUE RECOGNITION:** All revenue is recognized in the year in which it is received. Any Designated Income not utilized in the same year is held in a reserve fund within the operating account.
- **4. SHORT TERM INVESTMENT:** 3 investments are held with WFCU. 1) GIC 007 \$20,000 @3.35 1 year Cashable to mature Dec 7 2024; 2) GIC 008 \$50,000 @3.25% -1 year Cashable to mature Dec 7 2024; 3) GIC 005 \$11.486.61 @4.95% 1 year GIC to mature Jan 20 2024
- **5. MORTGAGE PAYABLE:** 4.5% mortgage, payable to Presbytery of Essex/Kent, repayable in blended monthly payments of \$506.12. Balance at Dec 31, 2023 is \$\$2,997.26
- 6. MONETARY DONATIONS for 2023 PWS&D \$4,311.65; Presbyterian Sharing \$5,295.34; Camp Kintail \$651.03; Soup Shack \$30; Total \$10,288.02
